# 2010 Scholarship Opportunity

## **B•Sew Inn Education Division FACS Student Scholarship**

**Award: \$500 scholarship**

**Eligibility:**

- 1) Applicants must be Arkansas high school seniors, during the 2009-10 school year.
- 2) Applicants must have completed a minimum of one semester of Family and Consumer Science classes during their high school years.
- 3) Applicant's High School Transcript must indicate that grades are acceptable for college or university admission
- 4) Applicants must have taken the ACT or SAT examination.
- 5) Applicants must have applied to a degree-granting institution leading to an associate's or bachelor's degree in any field of study.

**Regulations:**

- 1) All application material must be postmarked by April 24, 2010
- 2) It is the responsibility of the applicant to make sure that all materials are submitted. Applications with missing information will be automatically disqualified. Material must be submitted in one packet.
- 3) The scholarship is valid for one year. It can be used for either Fall 2010 or Spring 2011 semesters.
- 4) Scholarship recipient will be contacted on May 7, 2010 thru their respective school.

**Scholarship Application Instructions:**

- 1) Complete the attached form. Additional copies of the application form can be downloaded from [www.bsewinn.com](http://www.bsewinn.com) - Schools & Educator Tab - 2009-10 Scholarship
- 2) To the completed application form attach the following: a copy of your High School Transcript, which includes first semester of senior year. The transcript should also include standardized college entrance exam scores (ACT or SAT). It is also recommend that you attach a signed letter of recommendation from your Family and Consumer Science instructor. This is not a mandatory requirement, but there are points awarded accordingly.
- 3) Applications must be postmarked by April 24, 2010 and be received by the Education Division no later than April 30, 2010. The recipient will be notified thru their school on May 7, 2010. Please do not make phone or email inquires as to the recipients' identity. The appropriate school and student will be notified and if feasible we will post the information to our webpage.

**Procedure/Evaluation:**

This scholarship is a \$500 one time cash award per recipient payable directly to the college or university for either Fall 2010 or Spring 2011 semester. Funds must be applied toward tuition, room, and/or board. If not used for either semester, the funds will be forfeited. The Scholarship Committee will judge applications on style, expression, content, and organization of application materials.
